#### Course Overview

The purpose of this course is to provide health professionals information about the complex nature of suicide, how to assess, determine risks, and the appropriate treatment and management for at-risk patients both in the healthcare setting and the community. This 6 (six) hour class meets the requirements for the State of Washington mandatory suicide prevention training for health professionals and will include the special needs of the pediatric population.
