Waa maxay kaalmada dhaqaale?

Gobolka Washington ayaa uga baahan isbitaallada oo dhan inay siiyaan kaalmo dhaqaale (oo loogu yaqaan "Daryeel Samafal" sida hoos timaad sharciga gobolka iyo federaalka) bukaannada iyo qoysaska qanciya shuruudo dakhli qaarkood. Waxa dhici karta inaad u qalanto daryeel bilaash ah ama daryeel qiime-jaban oo ku salaysan tirada iyo dakhliga qoyskaaga, xataa haddii aad leedahay caymis caafimaad. Haddii uu ilmahaagu leeyahay Medicaid ama Apple Health, uma baahnid inaad codsato kaalmo dhaqaale.

Uqalmitaanka

Si aad ugu qalanto kaalmada dhaqaalaha, qoyskaagu waa inuu kasbadaa dakhli bishii walba ah in u dhiganta ama ka hooseysa 400% Heerka Saboolnimada Federaalka (FPL), iyada oo ku xiran tirada qoyska. Haddii aad shaqo ku kasbataan 401% ilaa 600% ee FPL, waxaad u qalmi kartaan kaalmada dhaqaale iyada oo ku salaysan heerar sii kordha. Booqo www.healthcare.gov FPL haatan jirta.

Maxaa la dabbaraa?

- Baaqiga bukaanka lagu leeyahay kaddib marka biilka lagu habsocodsiiyo caymiska iyo wax kasta oo ilo dhaqaale kale ah.
- Ku dallacyada hawlyaqaanada iyo goobta markay tahay goobta kasta ee Seattle Children's. Waxa kale ay dabbaraysaa adeegyada biilasha hawlyaqaanimada ay u soo dallacdo Seattle Children's daryeel bixiyeyaasha ku bixiya daryeelka isbitaallada kale.

Haddii aad u qalanto heerka sii kordha ee Kaalmadayada Dhaqaalaha, annagu kuguma dallaci doonno in ka badan "Caddadka Guud ahaan Lagu dallaco" (Amount Generally Billed) (AGB). Caddadka AGB waxaa la dejiyaa sanad kaste, waana caddadka isku celceliska ah ee aan ka helno caymiska nooc walba ah ee ku toosan daryeelka degdegga ah ama caafimaadka loogu baahan yahay.

Maxaa AAN la dabbarayn?

- Adeegyada la doorto ama la isku qurxiyo
- Tijaabinta hidde-wadaha si loo ogaado haddii xaalad hidde-wade loo soo gudbiyay carruurta mustaqbalka
- Adeegyada aan dhakhsaha ahayn ee ah marka Seattle Children's ay tahay ka baxsanaanta bahda qorshahaaga caymis.
- Adeegyada daryeelka caafimaadka ay soo dallacaan ururrada kale ee aan ahayn Seattle Children's

Ayaa u qalma?

Bukaannada da'doodu ka yar tahay 21 ee deggenaantooda ugu muhiimsani tahay Washington, Alaska, Montana ama Idaho ee qanciya shuruudaha dakhliga.

Bukaannada aan qancin shuruudahan ayaa laga yaabaa inay ugu qalmaan kaalmada dhaqaale kaliya adeegyada degdegga ah. Ka beddelka xubnaha ishaysta ee dadka ka soo jeeda Oregon iyo Hawaii ayaa waliba u qalmi kara. Waxa laga yaabaa inaan ka dhaafno marar dhif ah marka aanu adeeggu jirin meel ka baxsan Seattle Children's.

Maxaa dhacaya markay bukaannadu yihiin 21 iyo in ka wayn?

Bukaannadan ayaa dhici karta inay u qalmaan haddii ay oofiyaan shuruudaha dakhliga iyo:

- Haddii ay leeyihiin xaalado gaar ah oo sida ugu fiican ay Seattle Children's maarayn karaan takhassusayaasha xaaladda iyo barnaamijyada Seattle Children's
- Ay helaan adeegyada uurka
- Ay ka helaan daryeel Waaxdayada Degdegga ah
- Lagu baarayo si loogu sii wado daryeel dheeraad ah bukaan Seattle Children's oo ka yar 21 jir

Goorma ayaan codsan kartaa, oo intee in le'eg ayay jiri doontaa?

Waxaad codsan kartaa kahor, inta lagu gudajiro ama kaddib markuu bukaanku helo daryeelka. Marka kaalmada dhaqaale la oggolaado, waxay sida qaaliibka ah qaadataa 6 bilood. Kaddib markay ka dhacdo, waxaad karta inaad dib u codsato mar walba.

Maxaa dhacaya haddii aanan lahayn caymis? Wali ma codsan karaa?

Haddii bukaanku aanu lahayn caymis, ka wac lataliyayaashayada dhaqaalaha lambarka 206-987-3333. Kahor inta aanaan habsocodsiin codsigaaga kaalmada dhaqaale, waxaa laga yaabaa inaan hubino inuu bukaanku u qalmo Medicaid (Apple Health). Hadday u qalmaan Medicaid, waxa laga yaabaa inaad codsato taas kahor inta aanaan ka fiirsan kaalmada dhaqaale.

U oggolaanta iyo diidmada

Qofka codsaday ayaa ku heli doona warqad 14 maalmood gudahood kaddib markaan helno codsiga. Warqadda ayaa:

- Sheegi doonta haddii lagu oggolaaday ama lagu diiday, ama haddii aanu u baahan nahay wax kahor inta aanaan habsocodsiin codsiga.
- Sharraxi doonta sida loo gudbiyo racfaanka haddii lagu diido
- Kuu sheegi doona muddada adigu aad u qalanto

- Markaad joogto isbitaalka, weyddii kalkaaliyaha caafimaad ee ilmahaaga.

Seattle Children's ma u baahan yihiin caddayn dakhli ama lambar Sooshaal Sekuuriti?

Uma baahnin caddayn dakhli marka ugu horreysa ee aad codsanayso. Markaan dhammaystirno habsocodka codsiga midkoodba ha noqotee kaalmada dhaqaalaha ama Medicaid, waxa laga yaabaa inaan kuula soo xiriirno inaad na siiso caddayn qoran oo dakhliga ah ama caddayn sheegaysa in aanu bukaanku u qalmin il kale oo kharashka laga helo.

Annagu **uma** baahnin lambar Sooshaal Sekuuriti.

Financial Assistance Policy

Plain-Language Summary

What is financial assistance?

Washington state requires all hospitals to provide financial assistance (known as “Charity Care” under state and federal law) to patients and families who meet certain income requirements. You may qualify for free care or reduced-price care based on your family size and income, even if you have health insurance. If your child has Medicaid or Apple Health, you do not need to apply for financial assistance.

Qualifications

To qualify for full financial assistance, your family must earn a monthly income that is at or below 400% of the Federal Poverty Level (FPL), depending on the size of your family. If you earn from 401% to 600% of the FPL, you may qualify for financial assistance based on a sliding scale. Visit www.healthcare.gov for the current FPL.

What is covered?

- The patient balance after your bill is processed by insurance and any other funding sources.
- Professional and facility charges at any Seattle Children’s location. It also covers professional services billed by Seattle Children’s for providers who provide care at other hospitals.

If you qualify for our Financial Assistance sliding scale, we will not bill you more than the “Amount Generally Billed” (AGB). AGB is set each year, and it is the average amount that we are paid by all types of insurance for emergency or medically necessary care.

What is NOT covered?

- Elective or cosmetic services
- Genetic testing to find out if a genetic condition could be passed to future children
- Non-urgent services when Seattle Children’s is out of network for your insurance plan
- Healthcare services billed by organizations other than Seattle Children’s

Who is eligible?

Patients younger than 21 whose primary residence is in Washington, Alaska, Montana or Idaho and who meet income requirements.

Patients who do not meet these criteria may be eligible for financial assistance for emergency services only. Solid organ transplant patients from Oregon and Hawaii also may qualify. We may make rare exceptions when a service is not available outside of Seattle Children’s.

What about patients 21 and older?

These patients may be eligible if they meet income requirements and:

- Have specific conditions that are best managed by Seattle Children’s specialists and programs
- Receive prenatal services
- Receive care in our Emergency Department
- Are tested to further care of a Seattle Children's patient who is younger than 21

When can I apply, and how long does it last?

You can apply before, during or after the patient receives care. Once financial assistance is granted, it typically lasts 6 months. After it expires, you can reapply anytime.

What if I don’t have insurance? Can I still apply?

If the patient does not have insurance, call our financial counselors at 206-987-3333. Before we can process your application for financial assistance, we may have to check if the patient is eligible for Medicaid (Apple Health). If they qualify for Medicaid, you may have to apply for that before we can consider financial assistance.

Approvals and denials

The person who applied will receive a letter within 14 days after we get the application. The letter will:

- Say if you are approved or denied, or if we need something before we can process the application
- Explain how to turn in an appeal if you are denied
- Tell you the period of time for which you qualify

Does Seattle Children’s require proof of income or a Social Security number?

We do not require income proof when you first apply. As we complete the application process for either financial assistance or Medicaid, we may contact you for written proof of income or proof that a patient is not eligible for another funding source.

We do **not** need a Social Security number.

Free Interpreter Services

- In the hospital, ask your child’s nurse.
- From outside the hospital, call the toll-free Family Interpreting Line, 1-866-583-1527. Tell the interpreter the name or extension you need.

Seattle Children’s offers interpreter services for Deaf, hard of hearing or non-English speaking patients, family members and legal representatives free of charge. Seattle Children’s will make this information available in alternate formats upon request. Call the Family Resource Center at 206-987-2201.
